K&B's plantation shutters are manufactured with the highest quality materials designed to last in the harsh Australian climate. The warranty only applies to the original purchaser/end user. Any variation of this is at the sole discretion of K&B Security Doors and Shutters. All of our products are manufactured square.

*The shutter hardware used is covered by a manufacturer's warranty of up to 3 years.

Required Maintenance

All powder-coated and PVC/polymer surfaces with exposure to the sun, salt and pollution will fade/deteriorate over time without reasonable care and maintenance. K&B defines "reasonable care and maintenance" as ensuring the shutters are cleaned regularly to remove build-up of dust/dirt and pollution. This can be done with the use of a damp cloth, warm water and a neutral household detergent. Stubborn marks can be removed with a gentle application of a non-abrasive household cleaner.

Industry Standards

- Shutters that are manufactured outside of recommended sizing guidelines are sold with the provision they be operated with assisted close to counter the additional weight.
- Minor colour variations can occur between batches. K&B's shutters are sold with the expectation the product will be free of imperfections visible to the naked eye at a distance of 1.5m.
- Plantation shutters are not a complete block-out product (in regards to light). Product tolerances allow for gaps between the blades of 4-6mm.

Exclusions from Warranty

The following are examples of situations in which warranty would be void:

- 1. Incorrect use.
- 2. Abuse, fire, accidents, acts of nature or alteration to the original product/installation.
- 3. Damage caused by failing to adhere to the guidelines set out in the 'Required Maintenance' section.
- 4. Shutters that are manufactured outside of recommended sizing guidelines.

All powder-coated and mesh surfaces with exposure to the sun, salt and pollution will fade/deteriorate over time without reasonable care and maintenance. K&B defines "reasonable care and maintenance" as ensuring your security doors and screens are cleaned regularly to remove build-up of dust/dirt and pollution. This can be done with the use of a damp cloth/soft bristled brush, warm water and a neutral household detergent.

The following guidelines indicate the required frequency of maintenance for our *Supa Shield* 316 Marine Grade Stainless Steel Security Mesh:

CONDITIONS	DEFINITION	FREQUENCY
Mild	10km from coast. Rural/suburban area.	Every 6 months.
Moderate	5km from coast. High traffic area.	Every 3 months.
Harsh/Coastal	1km from coast. Heavy industry.	Every 3 weeks.
